### **Abstract**

The abstract of the article should consist of about 200-250 words. The abstract should be indented and positioned immediately before the body of the text, after the title.

**Keywords**— Minimum 3-4 keywords should be included.

**Body of the text:** Articles submitted for publication are evaluated in blind peer review. The identities of both the reviewers and the author are concealed from one another. Primarily the submitted articles will be considered by the editors for the confirmation of the standard and the scope of the journal. If any submitted article fails to fulfill primary standard, the same will be rejected and the author will be communicated the decision promptly. If the editors are satisfied, they will select two or more reviewers for detailed consideration of the articles. Receipt of work will be acknowledged as soon as possible. Authors will receive comments provided by the reviewers within one to two months. The editors may ask the author to revise the article for publication according to the suggestions and comments provided by the reviewers.

### **Heading**

**Subheading1:** Manuscripts are to be submitted in English or Assamese (only in case of language and literature). Authors must consistently follow British spelling conventions.

**Subheading2:** For articles: 5,000-6,000 words; for book reviews: 1,500-2,000 words. All portions of the articles should be 1.5 line-spaced.

**Reference style:** Articles published in the journal will follow the APA (American Psychological Association)/MLA (Modern Language Association) style of citation and reference.

Author's Last Name, First Name. "Title of Article: Subtitle if Any." *Name of Newspaper* [city of newspaper if city name not in name], Date of Publication, p. Page number if given. Name of Database, Permalink URL.

Author last name, First name. "Title of Article." *Website Name*, Day Month Year, URL.

***Journal Article:***

Author, A.A.. (Publication Year). Article title. Periodical Title, Volume(Issue), pp.-pp.
