It is hereby informed that any deserving student whose name has appeared in any of the merit lists but could not take admissions on account of flood situation during the stipulated period will be allowed to take admission during subsequent merit list admission periods and during Spot admissions. However, they have to inform college authority beforehand regarding their inability to take admission due to the flood situation. This means that if a student is listed in the First Merit List but is unable to take admission within the designated timeframe at any institution due to the flood situation, he or she may still be admitted during the Second Merit List dates or the Spot Admission phase.

In this regard, all concerned are kindly requested to adhere to the necessary instructions mentioned above to ensure that every deserving and eligible student is given ample opportunity to take part in the admission process.


